#### General Description

Bambusa arundinacea are members of the Graminae (Poaceae) family. Bamboos differ from the other members of the grass family by the presence of branches at each node. A bamboo culm consists of an internode (which is hollow for most bamboo) and a node, which is solid and provides structural integrity for the plant. Bamusa arundinacea reaches a height of 30 m, when fully grown, the main stems (culms) which are 15-18 cm long, are round, a few mm to > 30 cm in diameter and smooth and bear a profusion of very leafy branches.

#### Extraction

Bambusa Arundinacea Stem Extract is an extract of the stems of the Bamboo, Bambusa arundinacea, Poaceae.

- Decorative/ exfoliating component in cosmetic products.
- Herbal remedies.
