4 FIRST-AID MEASURES

GENERAL INFORMATION

Remove affected person from source of contamination. Perform artificial respiration if breathing has stopped.

NOTES TO THE PHYSICIAN

INHALATION

Move the exposed person to fresh air at once. Get medical attention if any discomfort continues.

INGESTION

If necessary, rinse mouth and provide fresh air. Get medical attention if any discomfort continues.
